# Netlist wins computer chip sales ban

## Judge grants motion for preliminary injunction against Diablo Technologies

An Irvine-based memory channel chip manufacturer secured a rare sales ban on controller chips produced by Canada-based Diablo Technologies Inc. and used in memory modules offered by Milpitas-based SanDisk Corp.

The preliminary injunction for Netlist Inc. against Diablo and SanDisk was confirmed Monday after U.S. District Judge Yvonne Gonzalez Rogers in Oakland rejected a motion for reconsideration in the ongoing breach of contract and trade secrets misappropriation case. *Netlist Inc. v. Diablo Technologies Inc.*, 13-5962 (N.D. Cal., filed Dec. 26, 2013).

The injunction order prohibits the sales and distribution of Diablo chips, which are used in SanDisk's ULLtraDIMM solid state drive (SSD) product line.

Prior to litigation, Netlist and Diablo agreed in 2008 to collaborate and trade confidential information to develop digital memory products.

Netlist now claims Diablo breached those supply and non-disclosure contracts when it allegedly used Netlist designs to develop its own memory channel chips.

"As the Court reads the Supply Agreement, based on the evidence in the record, Diablo had no other right to use Netlist's Technology or to use or make the Netlist Chipset for itself or anyone other than Netlist," Gonzalez Rogers wrote in her injunction order.

"Thus, the evidence strongly indicates that Diablo breached the parties' agreements, and that these breaches allowed Diablo to bypass many months in normal development time to get its own product to market," Gonzalez Rogers continued later in the order.

Jury selection for the case is slated to begin in March. SanDisk, a Diablo customer, is not named as a party in the underlying lawsuit.

Benjamin K. Riley, Netlist's lead counsel and a San Francisco-based partner at Bartko, Zankel, Bunzel & Miller, said his team was pleased with the result.

"We proved that Diablo obtained an unfair advantage over Netlist by improperly using the memory channel technology it learned from Netlist under the parties' contract," Riley said. "The injunction will help eliminate the unfair head start in the market obtained by Diablo, allowing Netlist to develop and sell its own cutting-edge memory products."

Fabio E. Marino, Diablo's lead counsel and a Menlo Park-based partner at McDermott Will & Emery, did not return requests for comment.

Netlist is also pursuing patent infringement claims against SanDisk. The breach of contract and trade secrets misappropriation case against Diablo and the patent case against SanDisk are both before Gonzalez Rogers and have been joined for discovery

Netlist is also pursuing patent infringement claims against SanDisk. The breach of contract and trade secrets misappropriation case against Diablo and the patent case against SanDisk are both before Gonzalez Rogers and have been joined for discovery

purposes. *Netlist Inc v. Smart Modular Technologies Inc.*, 13-5889 (N.D. Cal., filed Dec. 19, 2013).
